- **1. Call to Order:** President Maggie Rash called the Executive Board Zoom meeting to order at 12:02 p.m.
- **2. Approval of the Minutes** January 13, 2021.

MOTION: A motion by Mr. Gaines and seconded by Mr. Nyman to approve the minutes of January 13, 2021. Motion carried unanimously.

3. Treasurer's Report - September 2020:

Mr. Weaver presented the financial statements for December 2020 and noted the organization's good financial standing. BCATO is under budget largely due to cancelations of events during the pandemic.

MOTION: A motion was made by Mr. Gaines, seconded by Ms. Rash to approve the December 2020 Financial Statements; Motion carried unanimously.

4. President's Report

- A. PSATS Attendance- Due to COVID, the board had expressed concerns about reserving the Lodge/Conference suite for PSATS 2021. Ms. Rash relayed the cancelation policy for the suite at the Lodge/Conference Center which requires 72 hours notice for a full refund. In light of that information, Ms. Mulholland was directed to make the reservation.
- B. Resolutions-The Resolutions Committee presented the Resolutions Report* for the Annual Convention. Solicitor Clemons offered slight revisions for two of the resolutions for the purposes of clarity. The Executive Committee agreed with these recommendations and offered to assist with outreach to the BCATO members responsible for submitting the resolutions.

- C. Annual Convention- The Executive Committee reviewed and agreed via consensus on the proposed agenda.

5. Executive Director's Report Legislative Update-

- A. Ms. Mulholland reviewed potential speakers and topics for the Annual Convention, including the three Bucks County Commissioners, DA Matt Weintraub, and Dr, Damsker. There was Board consensus to pursue the above officials for the convention.
- B. Sponsorships- Ms. Mulholland provided the Board with an update on the revised 2021 Sponsors' support considering revisions to the Program due in part to COVID and adjustments to BCATO events.
- C. Golf Outing Update- Ms. Mulholland provided the Board with the final program for the day.
