1. Call to Order: President Maggie Rash called the Executive Board meeting to order at 5:35 p.m.

B. Consideration for Donation- Aware of the recent extreme weather events which included tornados and historic flooding, impacting Bucks municipalities and residents, President Rash and Ms. Lyons brought to the Board's attention a Disaster Relief Fund formed by the United Way of Bucks County and Penn Community Bank. The fund was created to assist residents faced with challenges related to the storms and long -term recovery. President Rash asked the board to consider a donation to which Ms. Lyons suggested \$5000. A motion was made by Ms. Algeo to donate \$5000 to the Disaster Relief Fund. Ms. Lyons seconded the motion and the motion carried unanimously.
