- **1. Call to Order:** President Maggie Rash called the Executive Board Zoom meeting to order at 12:02 p.m.
- **2. Approval of the Minutes –** of February 14, 2024.

**MOTION:** A motion by Ms. Rash and seconded by Ms. Schemm to nominate Mr. Nyman to serve as the 2024 BCATO 1<sup>st</sup> Vice President; Motion carried unanimously.

**MOTION:** A motion by Ms. Lyons and seconded by Mr. Lichtenstein to nominate Ms. Schemm to serve as the 2024 BCATO 2<sup>nd</sup> Vice President; Motion carried unanimously.

**MOTION:** A motion by Ms. Lyons and seconded by Ms. Schemm to nominate Mr. Weaver to serve as the 2024 BCATO Treasurer; Motion carried unanimously.

**MOTION:** A motion by Ms. Rash and seconded by Mr. Jones to nominate Mr. Deon to serve as the 2024 BCATO Vice Treasurer; Motion carried unanimously.

- B. **Annual Convention-** President Rash noted she received very positive feedback. Ms. Schemm thanked everyone for their support. Ms. Shortall stated everything was well done.
- **C. EMS Committee-** Ms. Rash noted that Bristol Township Fire Marshall, Kevin Dippolito attended the Convention and has been a valuable resource in planning the upcoming Emergency Service forum. FM Dippolito has expressed interest in joining the BCATO EMS Committee. Following discussion, the Board agreed to appoint Ms. Benitez and FM Dippolito as members of the BCATO EMS Committee.

### **5. Executive Directors Report**

- A. **Annual Membership Dues-** Ms. Mulholland explained that not all of the eligible townships have paid the full \$300. Ms. Mulholland reiterated that for the \$300, \$100 is applied towards the membership dues, \$100 is applied towards the Legal Defense Fund, and \$100 is applied towards the Municipal Initiative. After much discussion, the board agreed it would be best if Ms. Mulholland reached out to the individual municipalities.
- **B. Fall Event-**Ms. Mulholland informed the Board the Fall Event is confirmed with Hewn Spirits, at Peddler Village, for Monday, September 30, 2024. from 5:30 PM– 7 PM.
- **C. EMS Meeting-** Ms. Mulholland shared she visited the Northampton Fire Department and toured the new facility, and they are very receptive to hosting the forum. Discussion ensued and the morning of Saturday, June 8, 2024, was suggested. Ms. Mulholland will confirm the date with Fire Chief/ Supervisor Selisker. Several ideas for a framework for the program were enthusiastically discussed.
- D. **Visit to the Bucks County Emergency Operation Center** Ms. Mulholland confirmed BCATO will meet with and tour the Ivyland facility on Wednesday, Oct 9
